APPLICATION FOR MEMBERSHIP

Thank you for your interest in joining the Deep Cove Yacht Club

STEPS TO APPLY

1. Complete the attached Membership application form in its entirety and return it with the applicable application fee to the Office Manager.
2. Obtain signatures from TWO sponsors (from different memberships). Sponsors must be current voting members of the Club (Active, Senior or Life Members) and in good standing.
3. Applicants should ask their sponsors to go over the bylaws, rules & regulations of the Club with them.
4. Sign the application. Please note that signature indicates compliance and confirmation of the statement on the form – “I have read the Bylaws, Rules & Regulations of the Deep Cove Yacht & Sport Club”.
5. Applicants will be contacted & interviewed by the Membership Director and a Past Commodore.
6. All applications will be reviewed by the Executive Committee before being accepted. Reviews typically take place once per month.
7. The Membership Director will contact applicants upon acceptance/decline of the membership application.

ACTIVE MEMBERSHIP INFORMATION

- Active members have full membership of the Club, which includes:
 - One vote per membership at the Annual General Meeting
 - Moorage privileges on a seniority basis as slips become available
 - The privilege of holding office (a place on the Executive Board or Committee Chair)
 - A key to the Club, Wharves and Clubhouse
 - Full use of the Clubhouse and Outstation facilities
 - Reciprocal Moorage at participating clubs
- Membership priority is given to residents of the District & City of North Vancouver. Non-North Vancouver residents may be admitted at the discretion of the Executive.
- Active memberships may include the applicant’s spouse/partner, and/or children under the age of 19, as noted on the application form. Such named person(s) are referred to as “Family Members.”

ACTIVE MEMBERSHIP DUES

1. **Application Deposit:** A \$200.00+GST non-refundable deposit to be paid at time of application submission.
2. **Initiation Fee:** A one-time payment of \$9,800+GST (less any applicable age discount) as per the table below.
3. **Initial Membership dues:** Pro-rated from the date of membership acceptance until the end of the current calendar year.
4. **Annual dues:** The base rate annual dues are \$950.00+GST (less any applicable age discount), billed each January 1st

Please note: Initiation fees & any Membership dues should not be paid at the time of application. Once membership is approved you will be invoiced via the Office Manager, and dues will be required in full.

AVAILABLE 'CHANGE OF STATUS' OPTIONS

NON-RESIDENT MEMBERSHIP (Dues = \$190+GST)

Available only to current Active members who no longer live in the Lower Mainland. Non-resident members:

- May retain moorage seniority accrued while an Active, Senior, or Life Member
- May own and fly the Club Burgee
- Shall not accrue moorage seniority whilst a non-resident member
- Shall not have the use of the Outstation or club wharfs
- Shall not have a vote at general meetings or hold an Executive position
- Shall not retain keys to the clubhouse or wharfs
- Shall be required to reinstate Active membership status upon returning to reside in the Lower Mainland, and pay the differential in annual dues for the current year

SOCIAL MEMBERSHIP (Dues = \$380.00+GST)

Social membership is available only to current Active members. Social members:

- May have use of the Clubhouse
- Will forfeit any moorage seniority that was accrued while an Active member
- May have the option to return to Active membership, upon change of status application
- May be a member of Club committees
- May not vote at general meetings
- May not hold an Executive position
- May not retain keys to the Clubhouse and wharves and may not own the Club Burgee
- Have no moorage privileges and no reciprocal moorage rights

SENIOR MEMBERSHIP (Dues = \$475.00+GST)

Senior members have all the privileges and benefits of Active member status.

Senior membership is available only to current Active Members who:

- Have been Active members for a total of 25 years+
- Are 65 years and older

FULL TIME STUDENT MEMBERSHIP (Dues = \$100.00+GST)

Student membership is available only to current Active members who:

- Are full-time students aged 19-24 years
- Provide proof of full-time school registration via an enrolment letter or letter from their school institution

VOLUNTEER WORK PROGRAM

The Deep Cove Yacht & Sport Club has always encouraged and benefited from the use of time, energy, and expertise generously donated by its members. All Active, Senior and Social members are encouraged to donate volunteer hours throughout the year. A percentage of volunteer hours donated are credited from your annual membership dues for the following year.
